- 5. Sealed quotations must be submitted to this office by *hand* on or before 12:00PM on 2076/02/28. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2076/02/28 and time 1:00PM at this office. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum as listed below which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case, the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
