Invitation for Bids for the **Ward 02 Office Building Construction Work.**

1. The **Tokha Municipality** *has allocated funds* towards the cost of **Ward 02 Office Building Construction Work** and intends to apply part of the funds to cover eligible payments under the Contract *for 50/NCB/TM/W/2077-78*. Bidding is open to all eligible as per Section V of bidding document.
2. **Tokha Municipality** invites electronic bids from eligible bidders for the construction of **Tokha Municipality Office Building** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 3,59,68,000/- (in words Three Crore Fifty Nine Lakh Sixty Eight Thousand Only)**
 - Minimum Work experience of similar size and nature: **One with NRs.1,83,83,200/- (in words One Crore Eighty Three Lakh Eighty Three Thousand Two Hundred Only)**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Tokha Municipality, Majjuhiti, Kathmandu** and www.tokhamun.gov.np or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. Bidder must submit their bid electronically and download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document in the Rajaswa (Revenue) account of this office as specified below.

6. Pre-bid meeting shall be held at 11 am at 23 June, 2021.¹
7. Electronic bids must be submitted or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before July 04, 2021 at 12:00 PM Noon. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1 PM at the office on the same day. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 6,30,000/-(in words, Six Lakhs Thirty Thousand Only)**, which shall be valid for 30 days beyond the validity period of the bid (*i.e.120 days*)
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
