Invitation for Online Bids for the **Construction of Park at Kalkinarayan Premises**

1. The Government of Nepal **has allocated funds** towards the cost of **Construction of Park at Kalkinarayan Premises** and intends to apply part of the funds to cover eligible payments under the Contract **for 20/NCB/TM/W/2075-76**. Bidding is open to all eligible bidder as per Section V of bidding document..
2. **Tokha Municipality, Office of Municipal Executive, Maijuhiti, Kathmandu** invites electronic bids from eligible bidders for the **Construction of Park at Kalkinarayan Premises** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 18,761,000.00**
3. Minimum Work experience of similar size and nature: **At least 1(One) work with minimum value NRs. 20,000,000.00**
 4. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 5. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office: Tokha Municipality, Office of Municipal Executive, Maijuhiti, Kathmandu or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 6. Bidder must submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document of 5,000 (Five Thousand Only) in this Office Rajaswa (revenue) account as specified below .

7. Pre-bid meeting shall be held at **Tokha Municipality, Maijuhiti, Kathmandu** at 2019/06/09 at 12 noon at the office.
8. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 20 June, 2019. Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2019/06/20 at 1 pm** at **Tokha Municipality, Office of Municipal Executive, Maijuhiti, Kathmandu**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs. 4,85,000 (Four Lakhs Eighty Five Thousand Rupees only), which shall be valid for 30 days beyond the validity period of the bid.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
11. The office reserves the right to accept/reject the bid partly/wholly with/without assigning any reason whatsoever.
12. Any matters not stated in here are in accordance with prevailing laws of Nepal.
